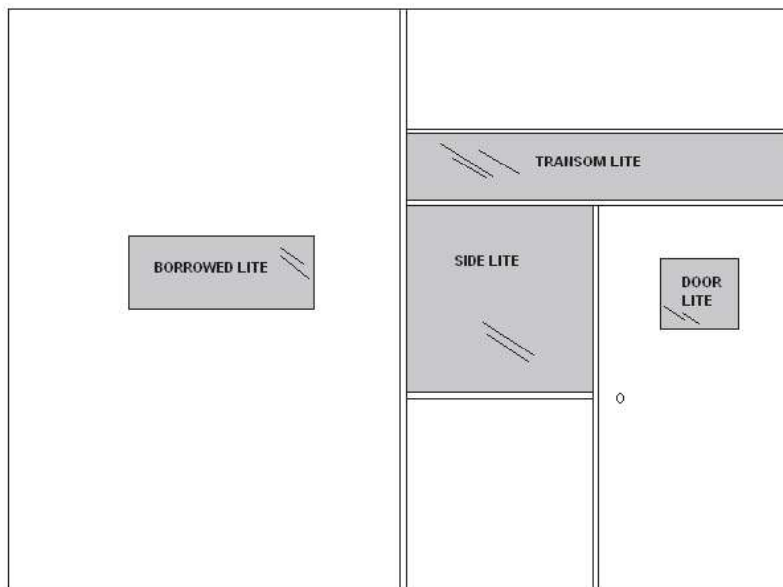


### Impact Resistant Glazing for Doors:

Swinging Doors are considered "Hazardous Locations" according to SECTION 2406.3 of the International Building Code, and require CAT II-rated glazing. Locations other than doors may not be required to have CAT II rating. Please consult your local (AHJ) Authority Having Jurisdiction to determine appropriate standards.
